**The Family Permit is defined as 1 head of household and 1 domestic partner, all unmarried children under the age of 21 with the same primary residence. Unmarried children living in the household who are 21 or older pay an additional \$50.00 at the time of application or pay full price at a later date. Married children of any age living in the household must pay full adult price. Grandchildren, nieces or nephews or other children living in the household may only be included if the head of household or domestic partner is the legal guardian of the child. Birth certificate, report card or driver’s license are acceptable forms of identification for children living in the household.*

Shaler Sea Dogs: All Shaler Sea Dog members must have a pool pass to participate. Shaler Township residents may purchase a Sea Dog Season pool pass for \$30.00. Non-residents must purchase a full price pool pass.

Children under the age of 6 who are Shaler Residents are not required to have a season pool pass, however the legal guardian of that child must have a season pool pass to qualify for the \$30.00 swim lesson rate. **Non-residents of Shaler Township must purchase a Non-Resident Pool Pass before Swim Lesson Registration to register their child for swim lessons.**
